

Austenasia Domain and Assets Transfer & Settlement Agreement

This Agreement is made between:

Andrew Musgrave (“Holder”)

and

The Operators of Austenasia.org (“Purchaser”)

Assets Being Transferred

The Purchaser agrees to pay the Holder:

£499.00 GBP

This amount represents the full settlement price for the assets above and reflects the costs incurred by the Holder to preserve and maintain the Austenasia domain and website up to 2 February 2026.

Ongoing Domain Costs After 2 February 2026

If the domain remains under the Holder’s control after **2 February 2026**, any additional domain renewal, server and PayPal fees incurred by the Holder after that date shall be added to the settlement balance.

Assets Being Transferred

Upon full settlement under this Agreement, the Holder shall provide:

- Transfer of the domain austenasia.com, and any associated domain names, including registrar and DNS control.
- A one-time export of the website files and database associated with the domains, provided “as-is”.

No hosting, VPS, server accounts, or cloud infrastructure are included.

Server Hosting Costs

The VPS and server infrastructure used to preserve the domain are owned and paid for by the Holder and are not part of the assets being transferred.

- If the Settlement Price is paid in full, the Holder shall continue to bear all VPS and server hosting costs thereafter at their own expense.
- If payment is made in installments and the balance is not yet settled, the Purchaser agrees that all domain renewal and server hosting costs incurred during that period shall be added to the settlement balance and paid by the Purchaser.
- If the Settlement Price is fully paid **before any additional VPS or domain renewal fees are incurred**, the balance shall be considered **settled in full**, even if the payment was made in installments. No later hosting or renewal costs shall be added after that point.

Transfer of Domain and Files

The Holder shall transfer the domain(s) and provide the website export within **seven (7) days** of full settlement under this Agreement.

If any registrar or domain-transfer fees are incurred in completing the transfer, the Purchaser agrees to reimburse the Holder for those costs.

Territorial Restoration

As part of this settlement, the Purchaser agrees to reinstate **Corinium Terentium** as a recognised territory within Austenasia in perpetuity.

This restoration shall take effect **immediately upon execution of this Agreement**.

This restoration does **not** grant the Holder any seat in Parliament or governmental office. The **Government of Austenasia** shall have exclusive authority to appoint or elect a new representative for the territory.

Dissolution of the Commonwealth of Austenasia

The Holder shall formally dissolve the Commonwealth of Austenasia within **seven (7) days** of full settlement under this Agreement.

Final Settlement

Upon completion of payment and transfer, both parties agree that all claims relating to the Austenasia domain, website, hosting, and related matters up to the date of transfer are fully settled and released.

Failure to Settle

If the Settlement Price is not paid in full, the Holder shall retain full ownership and control of the domain(s) and associated assets, and no transfer shall take place.

No Refunds or Offsets

All payments made under this Agreement are final and non-refundable. The Purchaser shall not be entitled to any reimbursement, offset, or claw-back of amounts paid, except as expressly stated in this Agreement.

Governing Law

This Agreement shall be governed by the laws of England and Wales.
